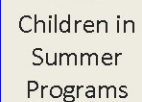

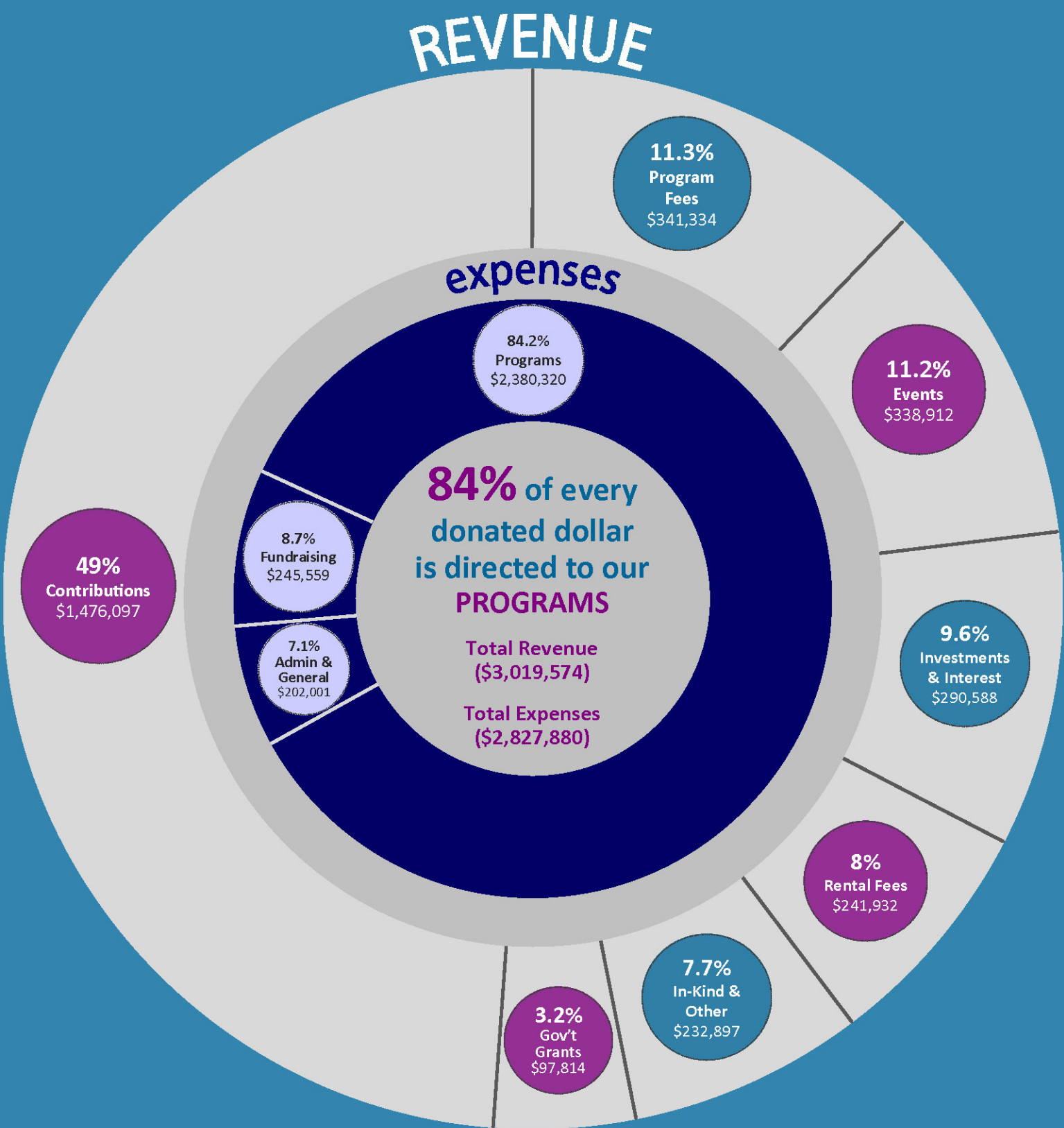

## After School Pilot Launched in Three Public Schools

In the spring of 2014, Carver Center launched a pilot After School Program at three public schools in collaboration with the Port Chester-Rye Union Free School District and support from a dedicated private foundation. The program was initiated to help cover the service gap created by the school district's loss of after school funding in the summer of 2013. The successful program served 60 children and will be developed into a full scale program.





# Youth Programs

**Mission:** The Youth Programs seek to successfully contribute to the learning and healthy development of children. Our **After School Program (ASP)** is licensed by the Office of Children and Family Services and provides children a broad range of activities that fall under four program areas: academic support, nutritional support, enrichment and recreation. The program both complements and distinguishes itself from the regular school day. Our **Summer Programs** offer many of the same components as ASP, but with a greater focus on enrichment and recreation to keep the summers fun. Our variety of **Saturday Programs** offer children the chance to explore specialty classes like martial arts, dance, and creative arts.

# TEEN CENTER

**Mission:** The **Teen Center (TC)** provides a safe and positive space where teens can participate in after school activities, build new skills, find support for life issues and prepare for the future. The programming options are diverse and include academic support and tutoring, athletics like basketball, soccer, and boxing, community service projects, workforce development and placement, college readiness and SAT courses, and cultural enrichment, among many others. All activities are designed to foster physical, mental, and emotional well-being for teens. We are empowering teens to be the leaders of the future!

# COMMUNITY & FAMILY SERVICES

**Mission:** The **Community & Family Services (CFS)** programs meet the nutritional, emotional, social service and other poverty related needs of Port Chester's lower income residents. Our primary services include emergency and monthly food assistance through our self-shopping food pantry and food delivery to homebound seniors. CFS also offer opportunities for growth and development through educational group workshops such as our couponing club. We make the most of our community resources and provide clients with advocacy counseling, referrals, furniture and clothing distribution, and support groups, among other services.
