Position Overview: The Nutrition & Wellness Assistant represents the Carver Center in the Port Chester community as a liaison between Carver guests, staff, and the community, maintaining the aesthetic appeal of the kitchen and ease of use, always with the guests' best interests in mind. The Food Services Assistant must have a passion for working with the community in programs that address food insecurity, nutrition, and wellness.

Position Specific Duties/Responsibilities:

- Coordinate with Nutrition & Wellness team members
- Assist the Lead Cook (Food Services) or Lead Market Associate (Carver Market), as needed
- Food preparation and cooking techniques
- Ability to use and maintain various stovetops and meat slicers
- Ability to wash, peel and cut vegetables
- Ability to use a wide range of kitchen ingredients
- Required knowledge of kitchen hygiene and food safety standards
- Attention to detail and interpersonal skills
- Assist with Retail Recovery Pick-ups and unloading
- Assist with afterschool food transport and drop off
- Ability to take inventory of items
- Other duties as assigned

- Ability to communicate effectively both verbally and in writing, be courteous in all dealings with clients, staff, and employees
- Demonstrate professional and ethical standards including confidentiality, courtesy, cooperation, positive attitude, reliability, punctuality, accuracy, efficiency, timeliness in respect to deadlines, and respectfulness toward others
- An interest in nonprofits, food security and nutrition, and community building
