1) THE CARVER MARKET IS A GROCERY STORE-STYLE FOOD PANTRY LOCATED AT THE CARVER CENTER. IN 2024-25 WE HAD 28,732 HOUSEHOLD VISITS TO CARVER FOR FRESH PRODUCE, MEATS, AND OTHER PROTEINS, DAIRY ITEMS, AND SHELF-STABLE GOODS. MUCH OF OUR FOOD IS PROVIDED BY FEEDING WESTCHESTER AND WE ALSO USE DONOR CONTRIBUTIONS TO PURCHASE FOOD FROM WHOLESALERS. STAFF MEMBERS USE CARVER'S REFRIGERATED VAN TO EXECUTE OUR RETAIL RECOVERY PROGRAM, WHICH RESCUES FOOD FROM RETAIL GROCERY STORES IN WESTCHESTER COUNTY. ALL THE FOOD IS OFFERED TO CLIENTS AT NO COST. WE DISTRIBUTED 700,583 POUNDS OF FOOD IN 2024-25. FAMILIES MAY SHOP AT THE CARVER MARKET ON A WEEKLY BASIS TAKING HOME GROCERIES VALUED AT AN AVERAGE OF \$175 PER VISIT.

2) CARVER CENTER'S FOOD SERVICE PROGRAM IS PARTIALLY FUNDED DURING THE ACADEMIC YEAR THROUGH THE CHILD AND ADULT CARE FOOD PROGRAM (CACFP), WHICH IS ADMINISTERED BY NEW YORK STATE DEPARTMENT OF HEALTH'S NUTRITION PROGRAM AND DURING THE SUMMER THROUGH NEW YORK STATE EDUCATION DEPARTMENT'S SUMMER FOOD SERVICE PROGRAM.
